



ERFC is looking for external evaluators

ERFC, Partner of “GREENLAND” project (co-financed under the ENI CBC Med 2014-2020 Programme) is looking for 3 external evaluators to support ERFC in its procurement procedures in the framework of the GREENLAND project.

1. GREENLAND Project description

The Mediterranean area suffers from extremely high rates of youth and female unemployment levels. To face this challenge, GREENLAND promotes social inclusion and fight against poverty by providing unskilled and underprivileged young people with marketable skills in the Green and Circular Economy, with the potential to generate thousands of jobs. To reach its objective, the project will create new curricula based on market needs, skills transfer to NEETs and women, media-based training tools, and facilitating cultural exchanges through young people. The creation of new employment opportunities will be reinforced by the sector-skills alliances between TVETs and SMEs.

2. GREENLAND project objective

To increase employability of NEETs (up to 30) and women (all ages) by providing with marketable skills and qualifications to prepare them for skill-based occupations within Green and Circular Economy sectors and reduce skill mismatches in rural areas particularly affected by the climate change.

3. Tasks/Responsibilities/Duties

The selected evaluators will act as an external selection committee in the procurements to be implemented by ERFC in the framework of the GREENLAND project. In particular, the selected evaluators will in each case:

- Study carefully the procurement notice/tender document issued by ERFC
- Evaluate the submitted offers against a set of predefined criteria
- Submit their evaluation result to ERFC

Indicatively, ERFC has a total budget of approx. Euros 74.000,00 for external services and Euros 17.000,00 for equipment in the framework of GREENLAND project.

4. Qualifications

- Bachelor's Degree / Master's degree / Other
- Experience of at least 5 years in the Green & Circular economy sectors
- Previous experience in EU funded projects
- Language requirement: proven proficiency in English is required.



5. Duration

The position has a duration till the end of GREENLAND project, which is April 2023, starting from the date of signing of the contract.

6. Payment

Total compensation for the duration of the engagement is Euro 800,00 excluding VAT, for each evaluator.

7. Tentative starting date

1st of January 2021.

8. Presentation of applications and selection procedures
