1a. CB CARBONFREE Project Description

Policies that increase consumer confidence in the environmental claims of green products will encourage greater consumption of environmentally friendly products even if those products were somewhat more expensive. The approach of the project is to train primary, secondary and tertiary sector staff and entrepreneurs involved in the agri-food sector on protocols for the use of reduced carbon footprints.

1b. MUSE Project Description

The project aims at strengthening the port museum system to enhance cultural and natural heritage for tourism purposes in some areas at high risk of abandonment / depopulation. The port museum is a kind of 'ecomuseum' that enhances the culture of the sea and of fishermen and the related productive activities through a participatory approach involving tourists to make the territories attractive. A new tourism enhancement model is proposed and described in the MUSE project for the cross-border area. This model is based on the historical, natural and cultural heritage and to the local population rather than pleasure boat ports. This network/system involves port museums already created (Tricase) and areas where the natural and cultural heritage linked to the values of port museums exist but are not fully established and developed (Messolonghi and Corfu).2a CB CARBONFREE project objective

The project aims to develop new innovations and/or improve existing production, standardisation and marketing methods, environmentally friendly,







focused on reducing the carbon footprint at

all stages of production, from the producer to the final point of sale. In this case, the project will provide the possibility, through the tools that will be developed, to support new innovative business practices in the cross-border area. The above framework is of great importance in the cross-border area where continuous support and training is deemed necessary.

The project will create a cross-border sustainable tourist destination by developing a network of three Port Museums (2 in Greece, 1 in Puglia Region), as three cultural expressions of three different coastal identities joined, however, by a common natural and cultural basis: the sea and local coastal communities. The project objective is to address the absence of efficient cross-border coordination in optimizing the results of tourism exploitation of the natural and cultural heritage.
